Separate sealed bids for **DRAINAGE IMPROVEMENTS FOR EDMUNDS STREET** will be received by the Town of South Boston at the office of their Engineer, B&B Consultants, Inc., located at 706 Hamilton Blvd., South Boston, Virginia until **May 4, 2017 at 2:00 p.m. (local prevailing time)** then at said office publicly opened and read aloud.

A non-mandatory pre-bid conference will be held on **April 18, 2017 at 10:00 a.m.** at the South Boston Public Works office at 710 Hamilton Blvd., South Boston, Virginia.

A Bid Bond payable to the Owner must accompany each bid for five (5) percent of the total amount of the bid. A certified check in the amount of not less than five (5) percent of the bid amount may be submitted in lieu of the Bid Bond.

A performance bond and payment bond, each in the amount of one hundred (100) percent of the Contract Price, with a corporate surety approved by the Owner, will be required for the faithful performance of the contract.

Evidence of proper registration with the Virginia State Registration Board of Contractors, pursuant to Chapter 7 of Title 54 of the Code of Virginia, must be submitted with each bid.

This project is funded in part by the Virginia Department of Transportation (VDOT). This procurement and resulting contracting shall be locally administered by the Town of South Boston in accordance with the Virginia Public Procurement Act.

All work shall conform to the latest revision of the VDOT Road and Bridge Specifications.

If a contract is to be awarded it shall be awarded to the apparent low responsive bidder determined from bids forwarded by Contractors.

Bids shall remain open for 60 days after the actual date of the opening thereof. Withdrawal of any bid due to error shall be in accordance with Section 11.54, Procedure (I), Code of Virginia, 1982.

The OWNER reserves the right to waive irregularities and informalities in bids received and to reject any and all bids and to award the contract where it appears to be in the best interest of the OWNER.
