Sealed Bids for the construction of the Halifax Road – Northbound Overlay project will be received by the Town of South Boston at the office of their Engineer, B&B Consultants, Inc., located at 706 Hamilton Boulevard, South Boston, Virginia 24592, until 2:00 p.m. local time on May 30, 2017, at which time the Bids received will be publicly opened and read. The Project consists of constructing:

- Base Bid
 - Maintenance of Traffic
 - Plane 1,166 SY of pavement
 - Tie-In Plane 939 SY of pavement
 - Eradicate all existing pavement markings
 - F&I 1,470 G of non-tracking tack coat
 - F&I 1,360 T of VDOT SM-9.5D surface asphalt
 - F&I 363 T of VDOT No. 25 or 26 aggregate material
 - F&I Type B, Class I pavement markings

- Alternate No. 1 Bid
 - Maintenance of Traffic
 - Plane 807 SY of pavement
 - Tie-In Plane 669 SY of pavement
 - Eradicate all existing pavement markings
 - F&I 535 G of non-tracking tack coat
 - F&I 495 T of VDOT SM-9.5D surface asphalt
 - F&I 122 T of VDOT No. 25 or 26 aggregate material
 - F&I Type B, Class I pavement markings

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis.

Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$30.00 per set, payable to "B&B Consultants, Inc.", plus a non-refundable shipping charge. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen.
